

The goal of the Financial Assistance Program is to help every child with cancer in need of assistance. We accomplish this by providing financial assistance so that parents can focus on their children.

Since our inception, the You Can Be My Angel has provided \$34,235 in direct financial assistance to three children struggling with various types of cancer. Our little heroes are: 1) Klaudia Pajak - this now seven year old was diagnosed with malignant cancer, stage IV neuroblastoma at age 5. Her treatment options were exhausted in Poland and her only chance was an anty GD-2 treatment offered in Greifswald clinic in Germany. This treatment, estimated at \$173,000, is not available in Poland nor is covered by the Polish National Health Fund. The Foundation contributed \$20,435 towards her treatment in Germany. 2) Szymon Pietko - Szymon was two years old when he was diagnosed with retinoblastoma, the most common malignant tumor of the eye in children. His only chance was a \$100,000 melphalan treatment in London. The Foundation contributed \$10,500 towards his treatment. 3) Oskar Wojcieszek - a four year old boy diagnosed in November 2012 with malignant cancer stage IV neuroblastoma. The Foundation contributed \$3,300 towards his treatment in Pediatric Institute of Oncology in Genoa, Italy.
