# Our Story



Once upon a time, a young boy named Jacob started our story of hope. One day, after a visit to the doctor, Jacob and his parents learned that he had an illness called neuroblastoma. He went through many treatments in Poland, among them: chemotherapy, bone marrow transplant and radiation. When it seemed that the cancer had subsided and his health returned to normal he had to return for yet another treatment.

The only option for Jacob was an antibody and interleukin therapy (Anti-GD2) available in Greifswald University Hospital in Greifswald, Germany. The cost of the antibody therapy was estimated at €80,000. The treatment, which is offered in the US, Germany, Italy and other European countries has not been approved nor is refundable by the Polish National Health Fund. With the help of many people of good heart his parents were able to raise funds and treat Jacob in Germany. Jacob is now seven years old and visits clinic for his scheduled checkups every three months.

While fundraising for Jacob we realized that we have the potential to help other children in need. It was for this reason the You Can Be My Angel Foundation was started. Our story came from humble beginnings; one child, one family, and one donation started a beautiful legacy. Our donors with little fanfare give generously to make amazing things happen. Our volunteers donate time towards ensuring our events and programs soar. We want to continue our story, our mission of providing encouragement, and to support children fighting cancer – because **every child with cancer deserves every chance to live.**



# Fundraising Events & Activities



The You Can Be My Angel Foundation held various fundraising events between March 2013 and March 2014 to raise more resources to reach more kids fighting cancer. 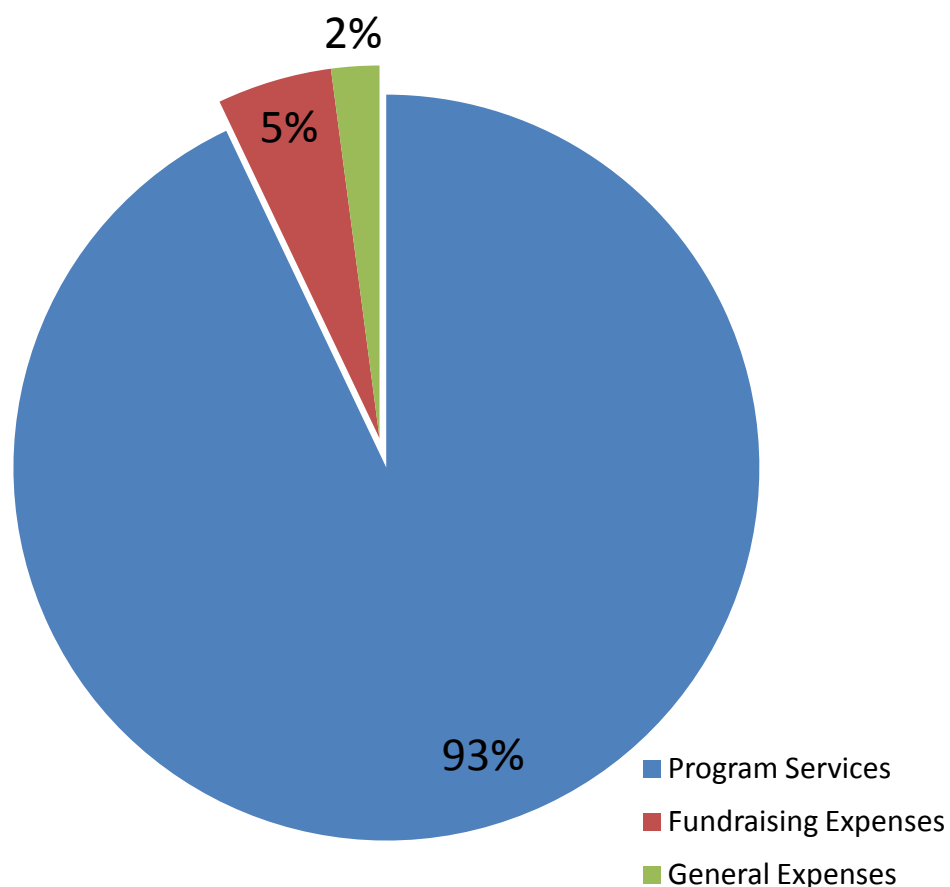
